## Packing list

- **One bag/one backpack on bus** (like flying on plane, one checked, one carry-on)
- **\*\*\*\*Money for 6 meals ( Lunch and dinner Thursday, Friday, Saturday) 4 of these meals will be at Disneyland and 2 will be more fast food type meals. Recommended amount is \$80.00. Students are welcome to bring snacks and a water bottle with them on the trip. Snacks and water bottles will also be available on the bus provided by our generous boosters.**
- Concert dress (includes shoes!)
- Modest dress/dress code clothing (not allowed: short shorts, clothes with holes, sleeveless shirts, strapless, spaghetti straps, bikinis, clothes with inappropriate images or slogans) The only exceptions to the dress code are basketball shorts for boys and leggings for girls. These can be worn while traveling.
- Clothes for Thursday-Saturday (include comfortable travel clothes and a swimming suit for the hotel if you would like to swim\*)
- Performance clothes:
  - **Please make sure all clothing is in good repair. Dress hems should be sewn and of a proper length. Please see the attached image that illustrates proper hem length\*. Please adjust your hem length BEFORE tour.**

### Choir:

Men: black slacks, tux shirt, bow tie, black socks, black belt, black shoes  
Women: choir dress, NYLONS (tights, etc.), black close-toed, low-heeled shoes

- Toiletries (toothbrush, toothpaste, shampoo, soap, etc.)
- Tablets and smaller technologies only. Please no computers, laptops, or gaming systems.
- Any movies viewed on personal devices must be G or PG
- Cellphones (bus conversations should be for emergencies only)
- Phone charger (bring an battery powered one as well if you have it)
- earbuds or headphones
- Sunscreen
- Spending money for souvenirs (if desired)
- Water Bottle (only water on bus; NO soda, juice, etc.), and snacks (if desired)
- Prescription medication (epi-pens, asthma)
- Homework to do on the bus
- Book to read on the bus
- Pillow and blanket for the bus

### Things NOT to bring:

- **powerful-smelling perfumes/cologne (bus), gaming consoles, weapons, inappropriate clothing**
- **Large electronics like laptops**

\* Bathing suit dress code:

There will be a pool at our hotel and we may have time to use it. If you choose to bring a bathing suit it must conform to the following guidelines:

Women: One piece suit that still keeps your stomach and everything else appropriately covered. If you do not have a ONE PIECE swimming suit, you must wear a t-shirt or swimming suit cover up IN and OUT of the water.

Men: A t-shirt is not required while swimming, but is required when in transit to and from the swimming pool.

**If a student chooses not to follow the dress code for swimming suits you will not be allowed to take part in swimming on this or any future BFHS music trip. Your director will decide if other consequences will be given for not following this guideline.**

**Release and Waiver of Liability,**

**Assumption of Risk and Indemnity Agreement**

IN Consideration of my minor student being permitted to participate in the Music Department Competition Trip with Benjamin Franklin High School (hereinafter "BFHS") and any related events and activities, I do hereby enter into this Agreement, on behalf of myself, my child\_\_\_\_\_ (hereinafter "Student"), my spouse, heirs, assigns, and next of kin, and do hereby agree as follows:

1. That I, my spouse, and Student Acknowledge, agree and represent that we understand the nature and risks of the BFHS Music Department Competition Trip and related events and activities (hereinafter "Activities") and that Student is qualified, in good health, and in proper physical condition to participate in such Activities. I, my spouse, and Student further agree and warrant that if at any time we believe conditions to be unsafe or that Student no longer qualifies or is not in good health or proper physical condition, I, my spouse, and Student will immediately discontinue Students further participation in Activities.
2. I, MY SPOUSE, AND STUDENT FULLY UNDERSTAND THAT: (a) BFHS ACTIVITIES INVOLVE SIGNIFICANT RISKS AND DANGERS OF SERIOUS BODILY INJURY TO STUDENT, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH (hereinafter "Risks"); (b) these Risks may be caused by Student's actions or inactions, the actions or inactions of others participating in the Activities, the condition in which the Activities take place, or THE NEGLIGENCE OF THE RELEASEES (hereinafter defined); (c) there may be OTHER RISK AND SOCIAL AND ECONOMIC LOSSES either not

known to me, my spouse, and Student or not readily foreseeable at this time; and I, MY SPOUSE, AND STUDENT FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES THAT I, MY SPOUSE, OR STUDENT may incur as a result of Students participation in the Activities.

3. I, MY SPOUSE, AND STUDENT DO HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE BFHS, it's owners, board members, officers, administrators, directors, employees, agents, volunteers, other participants in the Activities, sponsors or advertisers, and any affiliated entities of BFHS and their owners, board members, officers, administrators, directors, employees, and agents (collectively referred to as "Releasees") FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES, CAUSED OR ALLEGED TO BE CAUSED, IN WHOLE OR IN PART, BY THE ACTIONS OF RELEASEES, IN ANY FORM WHATSOEVER, WHETHER BY NEGLIGENCE OR OTHERWISE, INCLUDING BUT NOT LIMITED TO NEGLIGENT RESCUE OPERATIONS AND I, MY SPOUSE, AND STUDENT FURTHER AGREE that if, despite this AGREEMENT, I or anyone on my behalf or on behalf of my spouse or Student makes a claim against any of the Releasees, either collectively or individually, I WILL INDENIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney's fees, loss, liability, damage, or cost which may incur as the result of such claim.
4. I, MY SPOUSE, AND STUDENT do hereby agree to adhere to the rules and policies set forth by BFHS for the Music Department Competition trip, and understand that these rules and policies may be amended and/or modified at any time and at the sole discretion of BFHS.

6. If any portion of this Agreement is deemed to be invalid, the balance of the Agreement shall continue in full force and effect.
